NOW, THEREFORE, BE IT RESOLVED by the County Commission of the County of Miller, State of Georgia, as follows:

That Resolution #14-1029 hereby levies on taxable real and personal property in the unincorporated and incorporated areas of the County, the following Millage Rates to be distributed independently to the Miller County Board of Commissioners:




