

AGREEMENT

THIS AGREEMENT made and entered into this 12 day of November, 2012, by and between the **MILLER COUNTY COMMISSION**, the governing authority of Miller County, Georgia and the **DISTRICT ATTORNEY OF THE PATAULA JUDICIAL CIRCUIT**, as follows:

W I T N E S S E T H:

WHEREAS, heretofore, Miller County has had an elected solicitor of the State Court of Miller County to handle the prosecution and interest of the State in all criminal matters pending in the State Court of Miller County; and

WHEREAS, no one had qualified to run for the post of solicitor of the State Court of Miller County; and

WHEREAS, local and special legislation in Miller County provides that "in the event there is no elected solicitor of the State Court of Miller County, the governing authority of Miller County is authorized to appoint a qualified Assistant District Attorney of the Pataula Judicial Circuit to serve as a solicitor of said court with the approval of the District Attorney of the Pataula Judicial Circuit. Said Assistant District Attorney shall receive an annual salary fixed by the governing authority of Miller County for performing the services of solicitor of said court. Said salary shall be payable in equal monthly installments out of the funds of Miller County"; and

WHEREAS, the District Attorney of the Pataula Judicial

Circuit has approved the agreement between the Miller County Commission and his office providing for the use of an Assistant District Attorney to be the solicitor of the Miller County State Court; and

WHEREAS, the parties have agreed on a salary for said post and the terms and conditions upon which the same shall be paid; and

NOW, THEREFORE, for and in consideration of the mutual covenants and benefits flowing to each party hereto, the parties do contract and agree as follows:

1.

Beginning January 1, 2013, the Assistant District Attorney or Thomas Bishop or the designee from the Pataula Judicial Circuit District Attorney's office shall serve as the solicitor of the State Court of Miller County until there is an elected solicitor of the State Court of Miller County.

2 .

The Miller County Commission shall pay a salary of \$1,200.00 per month to the general account of the District Attorney of the Pataula Judicial Circuit.

3.

The Assistant District Attorney or his designee shall perform all duties of the solicitor of the State Court of Miller County, which have been heretofore performed by the elected solicitor.

4.

The Clerk of the Miller County Commission shall pay the above stated salary to the office of the District Attorney of the Pataula Judicial Circuit on the 1st day of each month during the term of this contract.

5.


All terms, conditions, and agreements are set forth herein and no modifications shall be effective unless reduced to writing and signed by both of the agencies hereto.
