

RESOLUTION 13-D708 A

RESOLUTION OF THE BOARD OF COMMISSIONERS OF MILLER COUNTY, GEORGIA FOR DISTRIBUTION OF EXCESS PROCEEDS OF THE ONE PERCENT SPECIAL PURPOSE LOCAL OPTION SALES AND USE TAX, ENACTED PURSUANT TO O.C.G.A. § 48-8-110 ET SEQ; REPEALING PRIOR RESOLUTIONS IN CONFLICT; AND FOR OTHER PURPOSES.

WHEREAS, O.C.G.A. § 48-8-110 *et seq.* authorized the imposition of a one percent county special purpose local option sales and use tax (SPLOST) for the purposes inter alia of financing capital outlay projects to be owned or operated by the County and one or more municipalities; and

WHEREAS, Miller County, Georgia, by and through this Board of Commissioners, has determined there exists excess proceeds of the 2006 SPLOST for the one or more of the purposes authorized by referendum under O.C.G.A. § 48-8-111 (a)(1) for projects thereunder, and said projects having been fully funded by the county and municipality therein; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Miller County, Georgia as follows:

SECTION 1. The disbursement of excess proceeds of the 2006 SPLOST received after completion of the approved projects among Miller County and the Municipality of Colquitt, to the Miller County General Budget is hereby approved pursuant to O.C.G.A. §48-8-121 for the purpose of in reducing debt or property taxes.

SECTION 2. The Board of Commissioners of Miller County, Georgia shall amend its 2006 SPLOST budget to disburse to its general budget the excess funds by an amending budget.

SECTION 3. This resolution is effective and implemented upon the counterparts of said intergovernmental agreement have adopted their respective resolutions authorizing the adoption of the said agreement.

SECTION 4. All resolutions, or parts of resolutions, in conflict herewith are repealed.
