NOW, THEREFORE, BE IT RESOLVED by the County Commission of the County of Miller, State of Georgia, as follows:

That Resolution #12-0830 hereby levies on taxable real and personal property in the unincorporated and incorporated areas of the County, the following Millage Rates to be distributed independently to the Miller County Board of Commissioners:


BE IT FURTHER RESOLVED that all Resolutions or Ordinances in conflict with this Resolution are hereby repealed.

HEREBY, PASSED, ADOPTED, and EFFECTIVE IMMEDIATELY after the first and only reading, this 30th day of August, 2012.




